**1° SCHOOL TUITION FEES 2026-2027 FOR THE SECONDARY  
SCHOOL:**

The tuition fees are divided in fees in Egyptian Pounds (EGP), fees in EUROS (€) as well as registration fees in Egyptian Pounds (applicable the first year of enrollment only OR if the outstanding balance from the previous year has not been settled on time).

Tuition fees for the academic year are payable in full regardless of the length of time the pupil attends the school and are non refundable. Parents are responsible for checking messages from the School on their WhatsApp account or their email regarding their financial situation.

### **3° FINANCIAL REGULATION:**

This Financial Regulation forms an integral part of the Enrollment Financial Agreement form entered into between the Parent(s)/Legal Guardian(s) (hereinafter referred to as the “Parent”) and the French School (hereinafter referred to as the “School”).

#### **1. Condition Precedent – Settlement of Previous Academic Year**

1.1. The execution, validity, and effectiveness of any Financial Agreement for a subsequent academic year shall be strictly conditional upon the full settlement of all outstanding tuition fees, charges, penalties, and any other financial obligations related to the preceding academic year.

1.2. The School shall not be obligated to execute or validate a Financial Agreement for the following academic year unless and until all financial liabilities from the previous academic year have been paid in full by the parent.

#### **2. Deadline for Settlement and Automatic Enrollment Fee Obligation**

2.1. The Financial Agreement for the upcoming academic year must be signed no later than June of the current academic year.

2.2. In the event that, at the time of signing or by the end of June of the current academic year, the tuition fee of current academic year has not been fully settled, the Parent shall automatically become obligated to pay the applicable enrollment fee for the subsequent academic year.

#### **3. Execution and Effectiveness of the New Agreement**

3.1. The School shall execute and countersign the Financial Agreement for the subsequent academic year only after: (a) all outstanding debts and financial obligations from the previous academic year have been fully settled; and (b) the first installment or required initial payment for the new academic year has been duly paid.

3.2. The Financial Agreement shall become valid and legally binding only upon signature by both the Parent and the authorized representative of the School.

3.3. In the absence of the School’s authorized signature, the Agreement shall have no legal force or effect.

#### **4. Exceptional Payment Arrangements in Case of Financial Hardship**

4.1. In the event that the Parent experiences temporary financial hardship and is unable to fulfill the payment obligations under this Agreement within the prescribed timeframes, the Parent may submit a written request to the School for consideration of a special payment arrangement.

4.2. Any exception or alternative payment schedule shall be granted solely at the discretion of the School and must be documented in a separate written agreement signed by both the Parent and the School.

4.3. Such separate agreement shall clearly specify the revised payment amounts and deadlines by which the Parent undertakes to fulfill the outstanding financial obligations.

4.4. Until such separate written agreement is duly signed by both parties, the original terms of this Financial Agreement shall remain fully valid and enforceable.

### **5. Withholding of Academic Confirmation and Official Diplomas**

5.1. In the event that any tuition fees, charges, or other financial obligations for the current academic year remain unpaid, the School reserves the right to withhold: (a) any official confirmation or certificate stating that the student attended or studied at the School; (b) any academic transcripts, reports, or records; (c) any diplomas, certificates, or official examination documents, including those obtained as a result of official examinations conducted in Cairo.

5.2. The above-mentioned documents shall not be issued or released until all outstanding financial obligations have been fully settled and cleared.

5.3. The School's right to withhold such documents shall remain in effect until the complete payment of all due amounts.

### **6. Refund of the School Fees or Compensation in Case of Early Departure:**

6.1 Annual school fees are payable in full, with no exceptions to this rule.

6.2 Parents are not entitled to any refund or compensation for early departure during the year for any reason whatsoever.

6.3 All enrolments in the school for the school year are final and cannot be postponed or adjusted.
